

GLOBAL FMCG COMPANY TO SECURE ACCESS RIGHTS FOR BEAUTY CARE

OBJ Limited (ASX:OBJ) is pleased to announce that a global FMCG company has commenced negotiations with the Company for a Joint Development Agreement (**JDA**) for the development and commercialisation of new products in the consumer health and beauty fields utilising OBJ's three core technologies.

This follows the successful completion of a year-long technical evaluation announced in September 2010.

Background to the Announcement

In September 2010, the Company entered into a Strategic Alliance with a global FMCG company to explore applications for the Company's technologies across a wide range of consumer product platforms. The technical evaluation undertaken under this agreement required OBJ to develop magnetic micro-arrays that demonstrated enhanced delivery of a number of key ingredient molecules used in the FMCG product portfolios. The results of this work were recently presented to the FMCG company by Mr Edwards, the Company's Technical Director, and Dr Kevin Hammond, the Company's International Partnering Manager. The results met the FMCG company's success criteria and the parties have now moved into negotiations for the establishment of a JDA in the Beauty Care field.
