- Analyses and reports on test activities, results, issues and risks, including the work of others.
- Assess risks and take preventative action.
- Identify improvements and contributes to the development of organisational policies, standards, and guidelines for testing.

Software development and Programming:

- Design, code, verify, tests, document, amend and refactor complex programs/scripts and integration software services.
- Contribute to the selection of the software development methods, tools and techniques.
- Apply agreed standards and tools to achieve well-engineered outcomes.
- Participate in reviews of own work and lead reviews of colleagues' work.

- Ability to multi-task and be comfortable with frequently changing priorities
