This role will be responsible for analysing and preparing regular management and regulatory reports, developing and maintaining key performance metrics, and performing ad-hoc analysis to deliver actionable insights.

The role is suited for someone who is inquisitive, attentive to detail, and is a strong communicator. This is a newly created role in a small but growing team. The candidate needs to be adaptive, flexible, and open to a broad range of challenging work.

What you will be doing:

 Work alongside members of the Listings Compliance team, Enforcement team and the Transformation and Operational Performance Team to understand pain points, process improvement opportunities using data analytics and deliver data analytics solutions to a wide variety of business problems.



- Design and develop various data products including dashboards, automated reports and monitoring tools to support the work of the wider ASX Compliance function.
- Develop and prepare timely and accurate performance, operational and risk metrics to include in regular management committee reports and regulatory submissions
- Perform a range of ad-hoc analyses to derive data-driven insights and present findings to nontechnical stakeholders in a way that is easily understood to support management decisionmaking
- Perform whole data analysis lifecycle, from gathering requirements, business analysis, sourcing and exploring data, data cleansing, data modelling, and reporting and visualization
- Work with cloud computing platforms and data visualisation tools to extract, manipulate and interpret data from a range of systems and data sources
- Collaborate cross-functionally with other ASX divisions to achieve collective goals.
- Develop an understanding of Listings Rules and the function's processes and procedures to monitor and enforce these rules
- Implement ways of working improvement initiatives including mapping of current state and development of future state business processes to improve capture of data and increase digitisation
- Undertake work assigned by General Manager or CCO

What you will bring:

- Tertiary qualification in a technical discipline such as computer science, data science, statistics, applied mathematics
- A minimum of 2 years' experience working as a data analyst or data scientist
- Strong Python, SQL and Excel skills to manipulate and transform data to derive meaningful insights
- Worked with cloud technologies such as AWS, Azure or GCP
- Experience working with data visualisation tools such as Microsoft PowerBI, Tableau, Tibco Spotfire
- Demonstrated ability to present data in a clear, logical, concise, contextual and visually appealing manner

Nice to have:

- Experience in regulation, supervision, compliance and/or risk management within financial services, ideally capital markets
- Experience with software development / engineering practices (DevOps, Git, MLOps, etc.)
- Experience working with emerging machine learning concepts, NLP or deep learning algorithms and libraries
- Experience in designing and building data products
- Have been involved in digitisation initiatives

- A learning and continuous improvement mindset, happy to share knowledge and learn from others
- Detail focused and proud of your sense of accuracy
