The ServiceNow PPM tool implementation team– is a run and change team delivering improvements to the delivery community.

PPM will be the source of truth for project and other data to provide an integrated view of project finances, resourcing and progress. It will enable demand management and portfolio management, providing real-time visibility into interdependencies, risks and change impacts. Insights and reporting will also be made available.

The Senior BA role will define the requirements/user stories that support the development and execution of the 'Strategy to Delivery' value stream product feature roadmap for release in alignment with ASX EC&O change package release mechanism.

Outside of the defined Senior BA role and responsibilities listed below, this role will be required to support Product Owner with the following:

1. Planning, developing, managing and prioritising backlog to meet business objectives and outcomes
2. Working with the team to deliver new and improved products and services through ServiceNow implementation
3. Transfer product knowledge continuously to the EPMO / SME's



ServiceNow exposure is highly preferable, but NOT required. Writing user stories, feature break down and backlog prioritisation capability and agile ways of working exposure required.

You are a practitioner/team member of the Business Analyst Capability Community of Practice (CoP).

What you will be doing:

This role will be responsible for the analysis and documentation of business and system requirements for assigned ASX initiatives and projects. Assessing new concepts against current systems and procedures, analyse stakeholder needs from an end-to-end perspective, engage internal and external clients through various facilitation techniques and mediums and provide high-quality, fit for purpose business analysis artefacts.

- > Engagement with internal stakeholders to elicit business- system- and operational requirements.
- > Strong collaboration with project assigned subject matter experts for articulation and definition of business processes and requirements.
- > Elicitation, preparation and generation of business requirements (including functional and non-functional) in the form of epics, features, user stories and acceptance criteria.
- > Preparation of business impact analysis documentation and workshop facilitation with each impacted business unit.
- > Analysis of current state processes and mapping of future state processes and associated models
- > Review and contribution to testing artefacts and approach.
- > Liaise with vendors and development teams on project progress, problem resolution and solution design.
- > Consultation with operational business units regarding deployment of system change, system functionality, system configuration and associated processes.
- > Produce high quality business analysis deliverables using relevant techniques and tools in line with the ASX delivery framework.
- > Being an active member of the BA Community of Practice (CoP)]

What you will bring:

- > Demonstrated 3+ years of Business Analysis experience and/or experience working in an analytical role.
- > Experience working on small/ medium a project across the full SDLC from early ideation to execution and embedment in BAU
- > Sound understanding of the business analysis fundamentals.
- > Effective communication, facilitation, influencing and negotiation skills. Can collaborate with stakeholders across seniority levels.
- > Demonstrable use of business process modelling and system design languages such as BPMN and UML.
- > Enjoys working in a fast-paced and evolving environment.
- > Work both independently and as part of a team.
- > Ability to look at big picture and at the same time, dive into the details.
- > Effective problem-solving skills, welcomes change and is adaptable within a very dynamic environment
