 projects.
- Apply agreed standards and tools, to achieve well-engineered outcomes.
- Collaborate in reviews of own work and lead reviews of colleagues' work.
- Responsible for interpreting and executing test scripts, analysing results and maintaining a defect register.
- Provide reports on progress, anomalies, risks & issues associated with assigned tasks.
- Support and implement the ASX Software Testing Policy and Guidelines within the context of the assigned work and tools used, and create and maintain documentation relevant to this.
