- Build & develop management reports and models to analyse financial performance
- Preparation of the monthly management and board reports, including reporting on ratios, key transaction and revenue statistics and KPI's

- Produce routine and ad hoc financial management information
- Ownership of half-year and year-end deliverables
- Lead and develop a management accountant in delivering the required outputs required of the team.

- Advanced excel skills

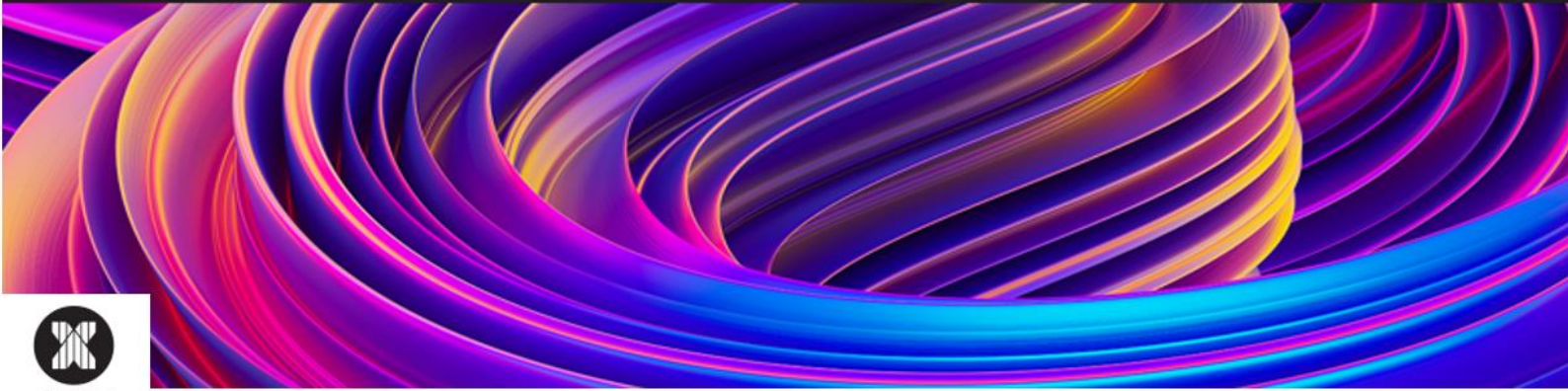
