  - Policy and regulatory areas of focus of the agencies with respect to the ClearStar program.
  - Information to be provided to the regulatory agencies to ensure that material project developments and risks are communicated in a transparent and timely manner.
- The coordination of, and preparation for, meetings with the regulatory agencies including the development of appropriate meeting materials.
- Timely provision of key project and program documentation to the regulatory agencies, including the risks and issues register, third party reviews, stakeholder consultation documentation, and written responses to their questions.
