² Other continuous disclosure queries are queries (other than price queries) raised by ASX with listed entities when ASX has concerns the entity may not be in compliance with its continuous disclosure obligations under Listing Rules 3.1, 3.1A and 3.1B. Examples include a query made following a media report or an announcement lodged with ASX.

³ Aware letters are sent by ASX following an announcement by a listed entity and ask for details of when the listed entity became aware of the material information contained in the announcement.

ASX RULE CHANGES, WAIVERS AND EXEMPTIONS

New and amended rules and procedures which enhance the ability of ASX Clear and ASX Clear (Futures) to recover from extreme stress scenarios became effective on 1 October. The amendments were required to comply with domestic and international regulatory requirements applicable to ASX Clear and ASX Clear (Futures) and were developed through extensive consultation with customers and regulators. They deal with:

- allocation of uncovered credit losses and liquidity shortfalls arising from a clearing participant default;
- replenishment of their financial resources following a clearing participant default; and
- allocation of investment losses incurred by ASX Clear and ASX Clear (Futures).

On 12 October, Procedure 10A.3.3 of the ASX Operating Rules was amended to include Barclays Global Aggregate Index as one of the fixed income indices for the purposes of admission as an AQUA product.

⁵ ASX is required, under sections 792B(2)(c) and 821B(2)(c) of the Corporations Act 2001, to refer a matter to ASIC if it has reason to suspect that a person has committed, is committing, or is about to commit a significant contravention of the ASX Group's Operating Rules or the Corporations Act. It should be noted that a single referral may relate to more than one potential contravention. It should also be noted that the fact a matter has been referred to ASIC does not necessarily mean that a contravention has been committed or that ASIC will take enforcement proceedings in relation to it.



On the same day, changes to the ASX 24 Operating Rules and Procedures associated with the launch of the Mini SPI 200™ Index Futures (S&P/ASX 200 Index) came into effect. The Mini SPI 200™ futures is similar to its parent SPI 200™ futures (AP) contract except that it has a \$5 tick value, not \$25.

Also on 12 October, the ASX 24 Operating Rules and Procedures were amended to support the introduction of the Eastern Australia Wheat Futures and Options. These new Eastern Australia Wheat contracts feature an expanded delivery arc covering Queensland, New South Wales and Victoria.

Guidance Note 7 *US Entities* – *Regulation S offerings on ASX* was updated as part of the ongoing review of ASX Listing Rules Guidance Notes.

Other minor changes were made in the month to:

- Guidance Note 1 *Admission as a Participant* for each of the ASX, ASX 24, ASX Clear, ASX Clear (Futures) and ASX Settlement Operating Rules;
- ASX Clear Guidance Notes 2 Resigning as a Participant and 5 Suspension and Termination of Participants;
- ASX Clear Futures Guidance Notes 2 Resigning a Participation; and
- ASX Settlement Guidance Notes 9 Offshoring and Outsourcing and 10 Business Continuity and Disaster Recovery.
