- In October 2020, total capital raised was \$7.6 billion, up 34% on the previous corresponding period (pcp).

## Trading – Cash Markets (including equities, interest rate and warrant trades)

- In October 2020, the average daily number of trades was 12% lower than the pcp. The average daily value traded on-market of \$5.2 billion was up 17% on the pcp.
- Volatility (as measured by the average daily movement in the All Ordinaries Index) was 0.8% in October (compared to 0.6% in the pcp).
- Expected future volatility (as measured by the S&P/ASX 200 VIX) in October was an average of 20.9 (compared to 13.6 in the pcp).
