Trading – Cash Markets (including equities, interest rate and warrant trades)

- In November 2022, the average daily number of trades was down 13% on the pcp. The average daily value traded on-market of \$6.077 billion was down 6% on the pcp.
- Volatility (as measured by the average daily movement in the All Ordinaries Index) was 0.6% in November, up 0.1% on pcp.
- Future volatility (as measured by the S&P/ASX 200 VIX) in November was an average of 14.7, compared to 12.8 in the pcp.
