





Project Update



Summary of market update

Project update issued on 28 March

- ITE1 testing is well progressed, since opening end November 2021:
 - 25 software providers working through testing the full coverage of functionality
 - The ledger is performing well and application code fixes are in line with expectations
 - The next software release, v1.3, will be tested and deployed by ASX into ITE1 in July
 - Accreditation can commence following applicable testing of v1.3 by software providers
- ITE2 environment will now open from 27 April 2022, rather than 18 April, to avoid the Easter and Anzac holiday period:
 - ITE2 open will commence with a dedicated onboarding period for the set-up of security certificates
 - CHESS user testing will commence following connectivity and onboarding and after v1.3 software release has been tested and deployed by ASX into ITE2
- Market Dress Rehearsals will not commence in October as previously advised
- There is a strong likelihood of a delay to the go-live date (April 2023)
- ASX will work with all stakeholders to assess flow-on impacts of these schedule changes to project milestones inc. industry testing, operational readiness, market dress rehearsals and implementation (go-live)



ITE1 – Software Provider Readiness



Software release v1.3 and technical accreditation

Key points and timeline

Key points and milestones

- Software release v1.3 will be deployed into ITE1 late July '22
- Accreditation can commence after software providers have completed relevant development and testing to v1.3
- Accreditation period will be subject to stakeholder input
- ASX is planning a further software release, v1.4, but it will not include any accreditation related changes



Software release 1.3

Scope

Functions re-instated:

- Class mergers
- Change of controlling participant

Defect fixes affecting connectivity and/or message accreditation:

All 'known issues' and 'defects', as published in Technical Documentation, will be resolved

Performance

• Performance improvements to key application processes including trade registration, batch settlement, EOD processing etc.

Technical requirements

- Technical support requirements for increased monitoring of application queues and processes to improve response time to customer queries
- Error code and descriptions for Ledger API users
- Expecting resets every ~3 months to allow environment data refreshes and patch releases



Failover and performance testing in ITE1

Key points and timeline

Failover testing

- Failover (simulated network outage) testing can commence after v1.3 has been deployed to ITE1
- Software providers will need to test their systems can reconnect and data integrity is retained prior to undertaking accreditation
- ASX will now publish the schedule for failover testing by June '22

Performance testing

- Performance testing can commence after v1.3 has been deployed to ITE1
- New performance tools will be provided for holding adjustments and trade registrations
- Software providers testing their interface under workload is not an accreditation scenario and therefore can be performed at any time in the ITE1 environment, subject to booking a test window and in accordance to performance test thresholds



ITE2 – CHESS User Readiness



ITE2 CHESS User onboarding

Timing and process for technical connectivity and set up

- Technical connectivity to ASX can commence as soon as <u>ITE2 applications</u> are approved and is already underway for many
 - If you would like to discuss or verify your ASX Net site codes please reach out via CHESSReplacement@asx.com.au
 - Clients are only required to connect from a single site, a secondary or DR site is optional for ITE2
- ITE2 opening has moved from 18 April, to commence from **27 April** with a **dedicated onboarding period** that will be phased, taking onboard learnings from ITE1 onboarding and testing
- The onboarding period includes certificate management set-up, as well as configuration for those wishing to use the CHESS Browser User Interface
- CHESS users will confirm access and set-up by sending a test message, completing the onboarding process
 - Any further testing during the dedicated onboarding period is not permissible
- CHESS users will need to work with their software providers to agree the right timing for software to be deployed to ITE2
 - Some may prefer to defer onboarding until nearer the start of CHESS user testing
- ASX expects to provide further guidance in May '22 on the window for CHESS user testing and when onboarding must start, subject to stakeholder input



ITE2 Operational Readiness Assessment

- Documentation on operational readiness and associated scenarios has already been published in the <u>Operational Readiness</u> Guide
- The majority of Operational Readiness scenarios have now been published, as at end March '22
- A fourth tranche of operational readiness scenarios will be published in April '22 for the remaining scenarios, including batch settlement and AMO exceptions (failure, recovery and session messages)
- A revised milestone for operational readiness assessment will be subject to stakeholder input



Market Dress Rehearsals (MDR)



Market Dress Rehearsals (MDR)

Updates relating to MDRs

- As part of the strategy for go-live preparation, the project will co-ordinate three MDR's with one scheduled contingency weekend
- As a result of the changes to near-term milestones, the first MDR will not be able to commence in October '22 as previously advised
- A revised timeline for MDRs commencing will be subject to stakeholder input
- ASX can now confirm the decision to use current dated (rather than prior dated) snapshot of data for MDRs
- Further details on MDRs, originally targeted for publication end of July '22, will also be reviewed
- We continue to ask for feedback on customer migration reports and run-book plans from CHESS users, however the previous deadline for feedback in June will now be deferred

Activities coming up

- ASX will actively work with all stakeholders to assess the flow-on impacts of any schedule changes to project milestones, including
 any revisions to the go-live date
- Implementation and Transition working groups will continue to provide updates on the approach and any flow-on impacts to project milestones
 - Next meeting will be scheduled in May '22 to provide further detail including when CHESS user testing may commence, subject to stakeholder input
- The new CHESS user working groups and the established software provider working groups will act as the primary engagement channel to elicit stakeholder feedback to ensure appropriate transparency and fairness
- Existing bilateral engagements with stakeholders will continue
- The outcome of stakeholder input and feedback will be disclosed to the market to support milestone changes including any
 revisions to go-live
