### 02 - Release 2 Timeline and Industry Testing



### Consultation feedback

- ASX received no specific feedback in relation to the proposed Release 2 go-live range in 2029
- > Feedback was generally supportive of the scope and structure of the proposed Software Provider and CHESS User test phases
- > Some respondents indicated concerns in relation to compressed timelines and overlapping testing activities, as well as the potential need for additional time to integrate their internal/vendor supported systems that connect to CHESS replacement into their back-office and other internal systems
- > Some respondents requested further details on the expected test phase activities to enable a more accurate estimation of the time required to complete each test phase
- > April, May and August appear to be the least challenging months for industry to go-live. Most respondents recommended avoiding calendar and financial year end.



### ASX's response


- > Three-month adjustment to Release 2 commencement, with the Software Build and Test phase now scheduled to commence in Q1 2026 to minimise overlap with Release 1 activities
- > Introduction of two industry timeline checkpoints aligned to the publication of the Release 2 Industry Test Approach and the release of functional and technical specifications
- > Adjustment to the Operational Readiness phase, which is now scheduled to commence in Q2 2028 and has been reduced to a three-month duration to allow more time for CHESS User testing prior to commencing Operational Readiness activities
- Allocation of an additional month for Dress Rehearsals and Parallel Testing as these phases coincide with the end of year shutdown period
- > CHESS User integrated systems development on the timeline is now shown on the Release 2 timeline.



### 02 - Indicative Release 2 Project Timeline Pre and Post Consultation Paper 2

ASX has made minor adjustments to address industry feedback regarding the time provided for Software Provider and CHESS User test phases:

- Adjustment to the commencement of Software Provider Build and Test phase
- Introduction of Industry Timeline Checkpoints
- Adjustment to commencement and duration of Operational Readiness phase
- Reflection of the period where CHESS User integrated systems development is to occur on the timeline
- Adjustment to Dress Rehearsals and Parallel Test phase

### 02 – Release 2 Implementation Approach



#### Consultation feedback

- > The majority of respondents did not express any concerns about the proposed approach
- > Some respondents highlighted the heightened risks associated with alternative approaches to implementing Release 2 as more than one release
- > Some respondents noted the importance of and need for comprehensive industry testing, multiple dress rehearsals and a rollback plan as critical risk mitigating activities for Release 2.



### ASX's response

- ASX is proceeding with implementation of Release 2 as one release, and implementation of the CHESS replacement solution over two major releases as planned
- ASX plans to mitigate the overall risk profile of Release 2 through comprehensive industry testing and readiness activities scheduled prior to go-live
- > The identification of specific implementation risks and risk mitigation measures have been informed by consultation feedback as well as through discussions with the Implementation and Transition Working Group.



### 02 – Release 2 Go-live Readiness



#### Consultation feedback

- > Across submissions, feedback highlighted the importance of:
  - Implementation Dress Rehearsals (IDRs)
  - ongoing industry engagement to ensure confidence in the cutover process
  - consideration of the unique needs/models/edge-cases of participants.
- > There was a general desire from some respondents to better understand the industry roll back approach and the need for timely access to documentation and detailed information.



### ASX's response

- Siven consultation feedback has not indicated concerns with the Release 2 go-live rehearsal approach, ASX intends to proceed with the approach as planned
- ASX plans that there will be a minimum of three IDRs as part of Release 2 Go Live readiness. Based on the outcome of the first IDR, ASX may elect to include an additional contingency IDR if required
- Release 2 cutover documentation is planned for publication in Q4 2027, and will likely include
  - Communication protocols
  - Validations
  - Roles and expected responsibilities
  - Rollback procedures as well as the details of customer migration reports to be provided
- > ASX proposes to engage with industry to establish a go-live decision framework that outlines industry readiness metrics to determine go-live readiness.



### 03 - Updated Release 2 Indicative Project Timeline for December 2024



### 03 – Timeline Checkpoints

Two new industry timeline checkpoints have been introduced to reflect industry feedback in relation to the proposed Release 2 build and test phases.



#### **Industry Timeline Checkpoint 1**

ASX proposes that the first timeline checkpoint will commence following the publication of the Release 2 Industry Test Approach document, which aims to provide the industry with a greater understanding of the industry test phases, activities and entry and exit criteria required for the phases.

#### Industry Timeline Checkpoint 2

ASX proposes that the second timeline checkpoint will follow the release of all functional and technical specifications, which will provide the industry clarity on the scope of change required to their systems and processes.



The intention is that at these checkpoints, the industry will have been provided the information required to form a view and advise ASX on whether there are any material risks or issues relating to their ability to continue meeting the Release 2 project timeline.


