

02 – Project Status

The project is tracking AMBER due to the flow on impacts from the delays in testing and the delays to the Data and Reporting build for CHESS replacement:

> Testing

- Testing for Drop 1 was completed on 13 November, two weeks behind schedule
- Testing for Drop 2 commenced on 14 November. Scope for Drop 2 has increased due to defects and blocked test cases carried over from Drop 1 testing
- The Project continues to prioritise scope and defects critical to AMO Build and Test and will have project resources progressing Drop 2 testing over the holiday period in late December/early January.

Data and Reporting build

- Replanning of the CHESS Replacement Data and Reporting Plan is in progress, including the prioritisation of reporting and internal system integrations essential to Release 1 go-live
- The build of the data and reporting steel thread has commenced with targeted completion in mid-December 2024. The purpose of the data and reporting steel thread is to prove out the end-to-end flow of data from BaNCS to the Data Platform, identify any early defects and obtain learnings that can be used for future build



02 – Project Status

Other key updates:

> Release 1

- 9 assurance reviews have been completed as at the end of November 2024. Refer to slide 14
- Non-functional testing has commenced with performance and resilience testing for the FIX Gateway
- Build for the AMO security details report is scheduled to start in January 2025 and is targeting AMO Readiness for availability.

> Release 2

- ASX's response to the Consultation Paper for Release 2 (CP2) was published on 26 November 2024. Key themes of ASX's response will be discussed in agenda item 3
- Release 2 planning continues with a focus on the requirements for Drop 1 and ISO20022 messaging.



03 – Release 2 Timeline and Industry Testing



Consultation feedback

- ASX received no specific feedback in relation to the proposed Release 2 go-live range in 2029
- > Feedback was generally supportive of the scope and structure of the proposed Software Provider and CHESS User test phases
- > Some respondents indicated concerns in relation to compressed timelines and overlapping testing activities, as well as the potential need for additional time to integrate their internal/vendor supported systems that connect to CHESS replacement into their back-office and other internal systems
- > Some respondents requested further details on the expected test phase activities to enable a more accurate estimation of the time required to complete each test phase
- > April, May and August appear to be the least challenging months for industry to go-live. Most respondents recommended avoiding calendar and financial year end.



ASX's response

- Three-month adjustment to Release 2 commencement, with the Software Build and Test phase now scheduled to commence in Q1 2026 to minimise overlap with Release 1 activities
- > Introduction of two industry timeline checkpoints aligned to the publication of the Release 2 Industry Test Approach and the release of functional and technical specifications
- > Adjustment to the Operational Readiness phase, which is now scheduled to commence in Q2 2028 and has been reduced to a three-month duration to allow more time for CHESS User testing prior to commencing Operational Readiness activities
- Allocation of an additional month for Dress Rehearsals and Parallel Testing as these phases coincide with the end of year shutdown period
- > CHESS User integrated systems development on the timeline is now shown on the Release 2 timeline.

03 - Release 2 Implementation Approach



Consultation feedback

- The majority of respondents did not express any concerns about the proposed approach
- Some respondents highlighted the heightened risks associated with alternative approaches to implementing Release 2 as more than one release
- > Some respondents noted the importance of and need for comprehensive industry testing, multiple dress rehearsals and a rollback plan as critical risk mitigating activities for Release 2.



ASX's response

- ASX is proceeding with implementation of Release 2 as one release, and implementation of the CHESS replacement solution over two major releases as planned
- > ASX plans to mitigate the overall risk profile of Release 2 through comprehensive industry testing and readiness activities scheduled prior to go-live.
- > The identification of specific implementation risks and risk mitigation measures have been informed by consultation feedback as well as through discussions with the Implementation and Transition Working Group.



03 – Release 2 Go-live Readiness



Consultation feedback

- > Across submissions, feedback highlighted the importance of:
 - Implementation Dress Rehearsals (IDRs)
 - ongoing industry engagement to ensure confidence in the cutover process
 - consideration of the unique needs/models/edge-cases of participants.
- > There was a general desire from some respondents to better understand the industry roll back approach and the need for timely access to documentation and detailed information.



ASX's response

- Given consultation feedback has not indicated concerns with the Release 2 go-live rehearsal approach, ASX intends to proceed with the approach as planned
- ASX plans that there will be a minimum of three IDRs as part of Release 2 Go Live readiness. Based on the outcome of the first IDR, ASX may elect to include an additional contingency IDR if required
- Release 2 cutover documentation is planned for publication in Q4 2027, and will likely include
 - communication protocols
 - validations
 - o roles and expected responsibilities
 - rollback procedures as well as the details of customer migration reports to be provided
- ASX proposes to engage with industry to establish a go-live decision framework that outlines industry readiness metrics to determine go-live readiness.

03 - Optional or Mandatory Nature of New Functionality



Consultation feedback

- Feedback received in relation to a number of aspects of Release 2 functional scope noted queries or concerns about the new functionality for CHESS replacement and whether this would be optional or mandatory
- > This included whether the functionality is mandatory for use (as outlined in ASX Operating Rules), and/ or is mandatory for a Software Provider to be accredited to use the system
- Concerns were also raised in relation to new functionality that isn't critical for the replacement of CHESS and whether this could add additional risk.



ASX's response

- Some of the new functionality proposed for CHESS replacement would require a 'critical mass' to be viable (such as Participants' support for non-batch DvP and Share Registry support for new corporate action services)
- ASX plans to engage further with industry on validating industry demand for any new services before proceeding with development. Functionality for discussion at this stage will include:
 - For any new fields in existing messages or subworkflows, it is expected that Software Providers will need to accredit to this functionality, with usage to be governed by the ASX Clear and ASX Settlement Operating Rules and Procedures, where relevant and appropriate
 - For standalone workflows, further work is required to assess whether they are optional or mandatory, as well as evaluating options for rollout.



03 - Optional or Mandatory Nature of New Functionality

Proposed process to determine whether new functionality for CHESS replacement will be optional or mandatory

Identify new or changing functionality



ASX will develop a list of new or changing functionality and a draft proposal as to whether it should be optional or mandatory for:

- Software Providers (i.e. accreditation)
- > Participants
- > Registries

Seek industry feedback via Technical Committee



ASX will seek for industry feedback on the proposal via the Technical Committee.

Revise initial proposal



ASX will revise the proposal based on industry feedback received and submit to the Technical Committee for recommendation.

Submit to Business Committee endorsement



ASX will seek for Business Committee endorsement for the optional/mandatory nature of new or changing functionality. Rules Consultation and Accreditation



The endorsed proposal will be used as input for the rules consultation and accreditation approach.



ASX aims to complete industry engagement on whether new functionality is mandatory or optional in 2025.

Consultation on ASX Clear and ASX Settlement Operating Rules reflecting the outcomes of these engagements is planned to commence in O4 2026.






ASX has made minor adjustments to address industry feedback regarding the time provided for Software Provider and CHESS User test phases:

- Adjustment to the commencement of Software Provider Build and Test phase
- Introduction of Industry Timeline Checkpoints
- Adjustment to commencement and duration of Operational Readiness phase
- Reflection of the period where CHESS User integrated systems development is to occur on the timeline
- Adjustment to Dress Rehearsals and Parallel Test phase

05a – Timeline Checkpoints

Two new industry timeline checkpoints have been introduced to reflect industry feedback in relation to the proposed Release 2 build and test phases.



Industry Timeline Checkpoint 1

ASX proposes that the first timeline checkpoint will commence following the publication of the Release 2 Industry Test Approach document, which aims to provide the industry with a greater understanding of the industry test phases, activities and entry and exit criteria required for the phases.

Industry Timeline Checkpoint 2

ASX proposes that the second timeline checkpoint will follow the release of all functional and technical specifications, which will provide the industry clarity on the scope of change required to their systems and processes.



The intention is that at these checkpoints, the industry will have been provided the information required to form a view and advise ASX on whether there are any material risks or issues relating to their ability to continue meeting the Release 2 project timeline.

05b – ISO Design Working Group

Update on the use of BIC

- > Member feedback has been provided on whether BICs should be retained for CHESS Replacement
- > Both UIC and BIC will be supported within the message schema
- > CHESS Replacement solution will only support a single identifier, UIC
 - Alignment to the TCS BaNCS product, which only supports a single identifier
 - Reduces complexity in the solution to only support a single identifier
 - AMQP will be the only message channel supported for ISO20022 for CHESS Replacement

Next Steps

- > Feedback received via the ISO Working Group wanted ASX to consider the usage of BIC in addition to UIC
- ASX is currently reviewing feedback and is proposing a deep dive on this topic at the next Technical Committee in February where potential solution options (technical and non-technical) will be provided to Technical Committee Members for consideration and feedback

05c – AMO Working Group

Summary Update of 14 October AMO WG

- > V1.1 updated FIX Specifications was published on 13 November 2024
- EIS queries supported in current CHESS are planned to be replaced by a FIX message and sent over the FIX interface. The unsolicited batch of FIX messages are expected to be sent automatically on FIX session establishment where the CompID subscription flag is set to TRUE
- > For Release 2, the use of account segregation functionality is still pending the outcome of industry consultation
- > Feedback was provided at the 28 September AMO WG meeting on whether current reference data could be provided instead of data from the previous day. ASX has proposed to apply reference data updates on the same day, meaning reference data is current. Due to operational constraints, this may result in the ITE environment not being available until 10am each day.

The proposed next steps of the CHESS Replacement scope objectives are categorised under one of the following:

1. Include in project scope and proceed to further detailed design

ASX plans to progress to develop detailed design and specifications with industry via BD WGs, ISO WG & I&T WGs. Electronic notification of payment advice and CUM entitlement balances will progress to further detailed design and specifications with adjusted approaches to address industry feedback.

2. Further engagement required

There are some aspects of the scope items that may require further engagement before proceeding to detailed design. These topics are planned to be taken forward via the Technical Committee and Business Committee in December 2024 and onwards into 2025.

3. Not in scope

These objectives have not received sufficient industry support and will not be brought forward through CHESS Replacement at this time.
