

Market Share - ON MARKET Traded Value and Trends






OFF-MARKET Value

CXA Lit Dark Pool / Internalised means Off Market 9.3% trades with price improvement. *Explanation of technical terms. Block Special – a crossing above the block special threshold which is executed off market and then reported to either ASX TRF or CXA TRF. Portfolio Special – a crossing of a portfolio of securities above the relevant threshold which is executed off market and then reported to either ASX TRF or CXA TRF. All of the above are included in the off-market reported value. TradeMatch is the ASX central limit orderbook. The TradeMatch totals include trades matched during the opening and closing auctions. Centre Point is the ASX anonymous mid-point matching service.
